BUSINESS BOOKKEEPING AND ACCOUNTING

The technical standards discussed in the following chart define performance expectations that must be met for advancement through and successful completion of the **Business Bookkeeping and Accounting Program**. It is the policy of Washburn Tech to provide reasonable accommodations for those with disabilities, health impairments, and other disabling conditions. Physical Demands / Motor Skills/ Sensory Skills	<ul style="list-style-type: none"> Candidate/Student must have the ability to perform physical activities that require considerable use of your hands and arms for repetitive use, sitting for long periods of time, and using sensory skills. This will include: oral comprehension, written expression, oral expression, speech clarity, near vision, and speech recognition. 	<ul style="list-style-type: none"> Sit in a chair for up to four hours with a short break. Listen and to understand information and ideas presented through spoken words and sentences. Read and understand information and ideas presented in writing. Communicate information and ideas in writing so others will understand.. Communicate information and ideas in speaking so others will understand. Speak clearly so others can understand you. See details at close range. Identify and understand the speech of another person. Open, sort, and distribute incoming correspondence, including faxes and email. File and retrieve corporate documents, records, and reports. Type 25 wpm to enroll in class, increase to 40 wpm over course of program.
Critical Thinking/ Observation/ Sensory/ Reasoning Skills	<ul style="list-style-type: none"> Candidate/Students must be able to use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions or approaches to problems. Be able to implement appropriate solution to a problem. Must also be able to be attentive in the classroom, observe demonstrations and participate in class. 	<ul style="list-style-type: none"> Give full attention to what other people are saying, taking time to understand the points being made, asking questions as appropriate, and not interrupting at inappropriate times. Understand written sentences and paragraphs in work related documents. Use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions or approaches to

		<p>problems.</p> <ul style="list-style-type: none"> • Understand the implications of new information for both current and future problem solving and decision-making • Manage one's own time and the time of others • Monitor and assess performance of yourself, other individuals, or organizations to make improvements or take corrective action • Organize things or actions in a certain order or pattern according to a specific rule or set of rules (patterns of numbers, letters, words, pictures, mathematical operations) • Recognize when something is wrong or is likely to go wrong • Generate or use different sets of rules for combining or grouping things in different ways
Behavioral / Social Skills and Professionalism	<ul style="list-style-type: none"> • Candidate/Student must have sufficient personal skills for successful interactions with customers, colleagues, supervisors, and from a variety of social, emotional, cultural, and intellectual backgrounds. Candidate/Student must be able to work independently in the program. 	<ul style="list-style-type: none"> • Take part in face-to-face discussions with individuals in work areas. • Demonstrate good personal hygiene. • Present professional conduct and appearance. • Be willing and able to work with others on projects. • Demonstrate attributes of empathy, integrity, concern for others, interpersonal skills, interest and motivation. • Must maintain client confidentiality. • Be an honest and ethical worker. • Be pleasant with others and display a cooperative attitude. • Be careful about detail and thoroughness in completing work tasks.
Communication Skills	<ul style="list-style-type: none"> • Candidate/Student must be able to communicate in English by speaking, reading and writing effectively. 	<ul style="list-style-type: none"> • Communicate effectively in writing as appropriate for the needs of the audience • Exhibit effective use of the structure and content of the English language including the meaning and spelling of words, rules of composition, and grammar.
Working Conditions	<p>.NOTE: At time of employment may be expected to have a resume, a valid Driver's License or means of transportation, pass a drug test, pass a background check, and Social Security number or documentation to legally work in the United States, may also be expected to take specialized test for specialty terminology, spelling, typing and other company related information.</p>	<p>NOTE: Many agencies and companies have specific requirements that must be met before hiring or accepting to be a part of an OJT experience.</p>
