The technical standards discussed in the following chart define performance expectations that must be met for advancement through and successful completion of the **Cabinet/Millwork Program**. It is the policy of Washburn Tech to provide reasonable accommodations for those with disabilities, health impairments, and other disabling conditions. These standards can also be used to determine whether accommodations or modifications are necessary and have been established through consideration by faculty and consultation with the following sources: consultation with the advisory committee for the program, The Vocational Rehabilitation Act, The Americans with Disabilities Act, Dictionary of Occupational Titles, O*Net Online developed for the U.S. Department of Labor.

<p>Physical Demands / Motor Skills</p>	<ul style="list-style-type: none"> • Candidate/Student must have the ability to perform physical activities that require considerable use of your hands, arms and legs and moving your whole body. This will include Extent Flexibility, Finger Dexterity, Manual Dexterity, Arm-Hand Steadiness, Trunk Strength, and Control Precision 	<ul style="list-style-type: none"> • Have the ability to bend Candidate/Student must have the ability to perform physical activities that require considerable use of your hands, arms and legs and moving your whole body. This will include Extent Flexibility, Finger Dexterity, Manual Dexterity, Arm-Hand Steadiness, Trunk Strength, and Control Precision, stretch, twist, or reach with your body, arms, and/or legs and doing such movements as climbing, lifting, balancing, walking, stooping, and handling of materials. • The ability to make precisely coordinated movements of the fingers of one or both hands to grasp, manipulate, or assemble very small objects. • Have the ability to quickly and repeatedly adjust the controls of a machine or a vehicle to exact positions. • Must have the ability to lift 50 lbs of weight. Ex. lifting power tools, compressors,, various tools and construction materials. • Have the ability to use your abdominal and lower back muscles to support part of the body repeatedly or continuously over time without ‘giving out’ or fatiguing.

<p>Observation/ Sensory/ Reasoning Skills</p>	<p>weaknesses of alternative solutions, conclusions or approaches to problems.</p> <ul style="list-style-type: none"> • Must be able to be attentive in the classroom, observe demonstrations and participate in lab classes. • Must have visual perception • Must be able to problem solve and diagnose including obtaining, interpreting and documenting data. • Must be able to recognize when there is a problem or possible problem. • Make themselves aware of their surroundings by using their senses. • Use mathematics (fractions, decimals, percentages, geometry, etc.) to solve problems • The ability to listen to and understand information and ideas presented through spoke words and sentences 	<ul style="list-style-type: none"> • Determining causes of operating errors and deciding what to do about it. • These observations require the functional use of vision, hearing, and other sensory modalities. • Combine pieces of information to form general rules or conclusions and to apply general rules to specific problems to produce answers that make sense. • Recognize abnormal mechanical sounds. • Recognize unusual smells such as motors and transformers burning. • Seeing abnormal conditions occurring in machinery operation. • Measure for building and determining size for cabinetry and be able to square, level, and secure cabinetry.
<p>Behavioral / Social Skills and Professionalism</p>	<ul style="list-style-type: none"> • Candidate/Student must have sufficient personal skills for successful interactions with customers, colleagues, supervisors, and from a variety of social, emotional, cultural, and intellectual backgrounds. • Must possess the emotional well-being required for use of their intellectual abilities, the exercise of sound judgment, the prompt completion of all responsibilities in the classroom and for lab projects. • Must be able to adapt to ever-changing environments, display flexibility, and learn to function in the face of uncertainties and stresses which are inherent in the educational process, as well as when dealing with clients, colleagues, and industry situations. • Must have the ability to develop organizational skills necessary to meet deadlines and manage time. • Student will be expected to learn and apply workplace responsibilities. 	<ul style="list-style-type: none"> • Have face-to-face discussions with individuals in work areas. Have good personal hygiene, professional conduct and appearance. • Be willing to work with others building team skills. • Demonstrate attributes of empathy, integrity, concern for others, interpersonal skills, interest and motivation. • Maintain client confidentiality. • Be an honest and ethical worker. Be pleasant with others and display a good-natured, cooperative attitude. • Be careful about detail and thoroughness in completing work tasks. • Maintain composure, keep emotions in check, control anger, and avoid aggressive behavior, even in very difficult situations.

<p>Communication Skills</p>	<ul style="list-style-type: none"> • Candidate/Student must be able to communicate not only in speech, but reading and writing in English. • Must be sensitive to multicultural and multilingual needs • Give full attention to what other people are saying or inferring, understand points being made, ask appropriate questions. 	<ul style="list-style-type: none"> • Write legibly, a thought on paper on how an operation of training equipment occurred. • Read and comprehend chapters in text and manuals and answer questions on the topics at hand. • Orally explain how you arrive at your completions on work stations. • English communication skills for necessary interaction with faculty, peers, customers, and others orally and in writing.
<p>Working Conditions</p>	<ul style="list-style-type: none"> • Candidate/Student will be working with hazardous chemicals. • *Must have the ability to work in various environments. • * Must meet work environment criteria at time of employment • Able to work with group or team. • *Wear protective safety equipment. <p>NOTE: At time of employment may be expected to have a resume, a valid Driver's License, be EPA certified in refrigerant handling, pass a drug test, pass a background check, and documentation to legally work in the United States.</p>	<ul style="list-style-type: none"> • Work with Solvents as well as mineral and synthetic oils. • Must be willing to perform at work stations with Safety in mind and will build on safety habits. • Must be willing to work at ladder heights, in attics, basements, crawl spaces, outside in good and bad weather, etc. <p>NOTE: Many companies have specific requirements that must be met before hiring.</p>
