Overview: Washburn Tech received grant funding from the Blanche Bryden Foundation to assist high school students who are eligible for free or reduced lunch at their home high school. To provide assistance to as many students as possible, the scholarship is limited to \$100 per semester.

Must provide documentation from the high school regarding eligibility for free or reduced lunch

Scholarship Awards: Applications for this scholarship are accepted throughout the semester, if funds remain available. Awards are granted on a first-come, first served basis to eligible students. Apply early as funds are limited.

This scholarship is not automatically renewable. However, recipients who continue to meet eligibility requirements, may request a renewal of funds for subsequent semesters within the same school year by sending an email request to tech-fa-info@washburn.edu.
